Dear Website Visitor,

We wish to inform you on the collection and use of your personal data when using our website. Your personal data is your details, such as your name, your address, your email address and your internet user behavior.

When you contact us, be it via email, telephone, post or contact form, we save the personal data you have given to us (i.e. email address, name, telephone number) in order to answer your inquiry. The legal basis for this behavior is art. 6 par. 1 p. 1 lit. f of the General Data Protection Regulation (GDPR). Any data we collect for this purpose is deleted as soon as we no longer need it or we limit processing when we are legally bound to save the information for a given period of time.

# Your rights

You have the following rights regarding your personal data:

- The right to information
- The right to correct or delete data
- The right to limit data processing
- The right to object to data processing
- The right to withdraw your permission, once given
- The right to data transferability

You also have the right to lodge a complaint with the data protection authorities concerning how we process your data.

#### Collecting personal data when you visit our website

When you visit our website for purely informative purposes, i.e. you do not register or transfer information to us in any form, we only collect the data that your browser has transmitted to our server. If you wish to view our website, we collect the data technically required to display our website and ensure its stability and security. The legal basis is art. 6 par. 1 p. 1 lit. f of the GDPR. This data includes:

- Your IP address
- Time and date of visit
- Time-zone in relation to Greenwich Mean Time (GMT)
- Requested content (specific site)
- Access status/HTTP status code
- Amount of data transmitted
- The website leading to our website request
- Your browser
- Your operating system and its interface
- Language and version of your browser software

### Objecting to or revoking the processing of your data

If you have given us permission to process your data, you may withdraw your approval at any time. A withdrawal effects the processing permissibility of your personal data the moment you have made your request.

You can object to our processing your personal data provided it is supported by the weighing of interests. Should you choose to object, we ask you to please state your reasons for requesting we do not process your personal data. We will then examine your substantiated objection with a view to the circumstances and will either cease processing your personal data, adapt processing accordingly or clearly define for you our compulsory, protection-worthy grounds for continuing processing.

#### Incorporation of services and third-party content on our website

The legal basis for using these services and the related processing of personal data emerges from article 6 par. 1 p. 1 lit. f of the GDPR. We hold a justified interest in operating, optimizing and displaying our website.

When you visit our website, your personal data will certainly not be transferred to social media providers directly. You can recognize social media providers by their initials or their logo. We merely offer you the option to follow links that open the corresponding social media websites.

Neither do we possess information on the deletion practices of social media website providers.

This way you avoid automated allocation to your account by social media providers.
